PHYSICAL DEMANDS OF THIS PROFESSION--

This profession requires no heavy lifting. Professions for Cosmetology Operators and Cosmetology requires standing 85% of the time, walking 10% of the time, and sitting 5% of the time. Professions for Manicure Specialists requires standing 5% of the time, walking 10% of the time, and sitting 85% of the time.

SAFETY REQUIREMENTS OF THIS PROFESSION--

Anyone involved in this profession should take precautions to prevent adverse reactions to allergens caused by chemicals used in the profession that are inhaled or come in contact with the skin. Also, exposure to germs from the general public is common.

LEAVE OF ABSENCE POLICY

The school has a Leave of Absence Policy that applies to all students. All leaves of absences must be requested in writing by the student in a signed and dated format. However, if unforeseen circumstances prevent a student from providing a prior written request, the institution may grant the student's request for a leave of absence. In this case, the leave will be documented in the student file and the written request is requested at a later date. Leaves of absence must be approved by the director of the school. A leave of absence and any subsequent leaves of absence may not exceed 180 days in any 12-month period. A student not returning to school at the end of a leave will be withdrawn the program with the last date of attendance being the withdrawal date.
